**To show at Ak-Sar-Ben, feeder calves must have a certified birth date, be out of an identifiable sire and dam, be the product of the 4-Her's breeding stock, not purchased or leased, must have a 4-H ear tag and be identified by the deadline. Market Beef - No Nose print in 2008.

***4-H Ear tags may be an acceptable method of identification for showing at the County fair level only. Check with your county staff for requirements for your county fair. If you choose to use ear tags County staff will need to visit your farm by June 15th to verify that ear tags are in the pig's ears. Fresh ear notches will be reason for disqualification.
